1. Keep the user manual

2. Safety instructions

⚠ Warning: Keep the work area clean and tidy at all times. A cluttered work area or workbench increases the risk of accidents. Spilled degreaser must be cleaned up immediately.

- Familiarize yourself with the machine's applications, limitations, and specific potential hazards. Read the entire operator's manual carefully and familiarize yourself with it.
- Always wear appropriate protective clothing, gloves, and safety glasses that meet the latest European safety standards. Regular glasses do not provide adequate eye protection.
- Remove any spilled degreaser from your skin immediately. Consult a doctor immediately if necessary.
- Always carefully follow the degreaser manufacturer's instructions.
- Before use, check the machine for damage. Any damaged parts should be inspected to ensure they are functioning properly and can perform their intended function. Damaged parts should be repaired or replaced appropriately. If in doubt, do not use the machine and contact your local dealer.
- Always disconnect the degreaser from the power supply before carrying out any maintenance or cleaning work.
- Always keep your work area clean and tidy. A cluttered workspace or workbench increases the risk of accidents. Spilled degreaser should be cleaned up immediately.

Important

The spring/lid system is designed to hold the hood open during use.


- **Always close after use.**
- **Prohibited: leaving the degreaser container open unattended.**

Caution! The degreaser tray is intended for cleaning/degreasing parts with a suitable (preferably water-based), non-aggressive cleaning fluid with a flash point above 66.5°C. The fluid is circulated via a pump and nozzle/outlet.

3. Environment & disposal

Dispose of used degreasing agents according to applicable environmental regulations. Do not discharge into sewers.

6. Application

Suitable for:

Workshops and maintenance areas

- Cleaning metal parts
- Removing oil, grease and dirt

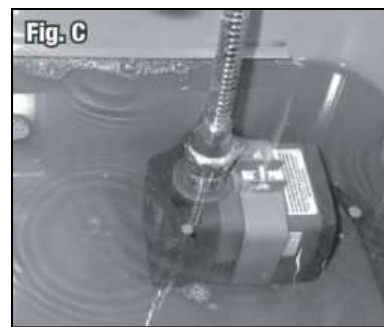
Not suitable for:

Flammable or explosive liquids

- Strongly corrosive agents
- Plastics that cannot withstand degreaser

7. Montage

1. Screw the flexible metal fluid outlet tube onto the pump outlet fitting (Fig. A).
2. Place the parts cleaning tray over the ledges on the tray walls. Make sure the nozzle of the flexible metal "gooseneck" fluid outlet tube is shaped so that it points inward and downward, toward the center of the tray (Fig. B).
3. Fill the unit with a suitable water-based degreasing solution, enough to cover the entire pump (approximately 3.5 gallons) (Fig. C).



Important notes:

- Before using the degreasing solution, carefully follow the mixing, usage, and safety instructions on the label.
- Make sure the detergent level completely covers the pump, otherwise it will not work properly.
- Connect the power cord to an approved, grounded, earthed electrical outlet with a Ground Fault Circuit Interrupter (GFI). 230V/50Hz (120V/60Hz).
- Turn the power switch to "On." The parts cleaner is now ready for use.

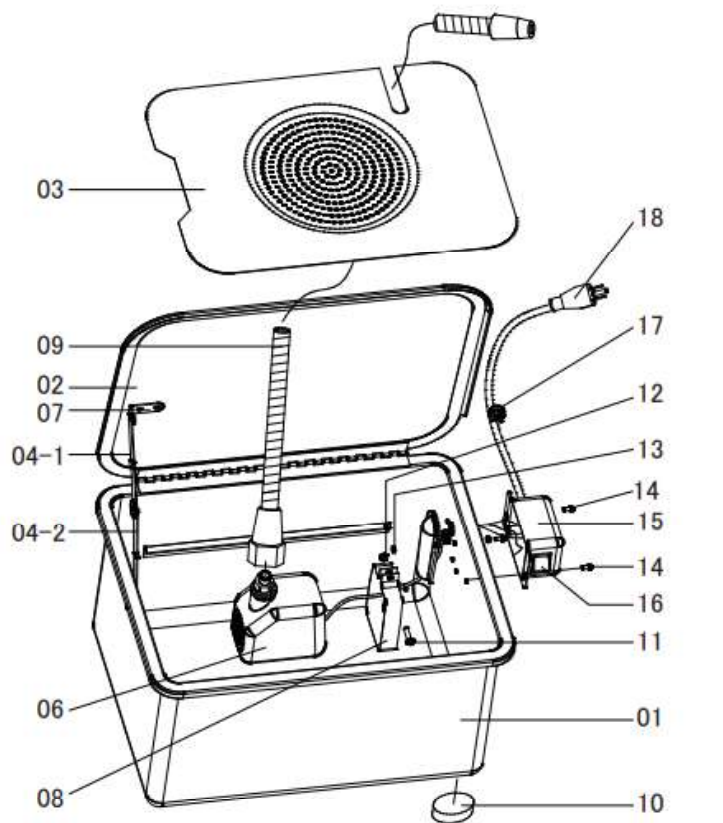
8. Use

1. Open the lid.
2. Place the part in the degreaser tray.
3. Turn the switch to ON.
4. Clean the part with the flexible rinse hose.
5. Let the liquid drain back into the container
6. Turn the switch to OFF after use.
7. Close the lid.
8. Clean up spilled liquid immediately.

9. Fire safety

- The lid holder contains a fuse that will close the lid in the event of a fire. This fuse is not resettable and must be replaced after activation.
- Do not place the unit near open flames, sparks or other flammable conditions.
- Closing the lid can limit the spread of fire.
- Make sure that appropriate fire extinguishing equipment is available at the degreaser tank.
- Close the lid after each use.

12. Maintenance

- Unplug the pump and check the pump inlet screen after every hour of cleaning (Fig. D). Clean more often if there is excessive grease and dirt buildup.



Important Note: Failure to clean the pump inlet will result in reduced fluid flow, lower cleaning effectiveness, and ultimately pump motor failure.

If it becomes apparent that the pump suction screen needs to be cleaned more often, it is likely that the cleaning fluid needs to be replaced and that sediment has built up from the bottom of the tub. Drain the drain and pour the cleaning fluid into suitable containers. Then dispose of it properly.

13. Troubleshooting and solutions

Fault	Cause	Solution
Pump not working	No tension	Check plug/fuse
Poor cleaning	Fluid contaminated	Replace fluid
Leakage	Drain plug loose	Tighten

14. Warranty

Warranty Terms and Conditions

1. This warranty shall enter into force on the date stated on the original purchase invoice and shall remain valid for a period of twelve (12) months.

8. Any repair work must be carried out exclusively by the supplier or an authorised service partner. Repairs performed by unauthorised third parties shall immediately void all warranty rights.
9. Repairs performed during the warranty period shall not result in an extension of the original warranty period. However, a separate warranty period of three (3) months shall apply to the repaired components, provided that the original warranty period has expired.
10. All maintenance and servicing operations described in the user manual must be performed in a timely and proper manner. Failure to do so may result in the warranty becoming void.
11. Warranty claims may only be submitted to the original point of sale at which the product was purchased.
